### 9. Presentation – Hal Sanford, SRJC Forensics

# 12. Executive Director's Report – Kate McClintock

## YTD Gift Report

Kate reviewed the YTD fund development data. She reported the Foundation has received \$4.6 million YTD compared to \$3 million YTD last year. The Foundation has raised \$4.3 million toward the SRJC 100<sup>th</sup> Anniversary Campaign including named reserves for the Burbank

Auditorium Endowment. In reviewing the detail, Kate noted that a total of 40 donors have contributed \$3.5 million in gifts. She re-emphasized the importance of individual donors at the major gift level.

She announced the anonymous donor was Mr. Robert Harris. Mr. Harris gifted \$6 million to SRJC student scholarships. Kate, Dr. Chong, and foster student recipient Harmony Simmons-Caponio attended a memorial for Mr. Harris. Mr. Harris requested his endowment be renamed the Harris Family Charitable Trust upon his passing.

### 17/18 Scholarship and Program Endowment Report

Kate reported that the Foundation remains number one among California Community College's for scholarship awards. The scholarship payout remains at 3.5% averaged over five years. In this fiscal year 12 new endowments have been added totaling \$300,000 and will distribute \$10,000 in awards to students. Scholarship award focus areas include: athletics, health sciences, art, history, viticulture, hospitality, culinary, foster students, single parents, public safety, math, and fashion. Kate estimated a total \$3.7 million of all scholarship awards (endowed and non-endowed), including Doyle will be awarded to students. A full report available upon request.

Kate requested approval to distribute scholarship and program awards for the 17/18 Fiscal Year. Kent motioned to approve scholarship and program distribution report.

Sarah reported on the status of the 16/17 President's Circle and reminded board members that 50 percent of donations came from two individuals. She shared information about the upcoming Giving Day planned for fall which will offer a premium to donors at a specific level. The premium will be an item such as a wooden bottle stopper, which was crafted from the iconic oak tree which fell down during a storm in 2014. She also shared that the college has provided a list of "lost alumni" from the 1990s who will be contacted for the SRJC 100<sup>th</sup> Anniversary.

Breanne reported on an upcoming full-page ad featured in the non-profit issue of North Bay Biz Magazine, ongoing Press Democrat "Celebrate Community" ads, and a feature story in "Sonoma Gives," a special edition of the Press Democrat. She noted that the Foundation feature in Sonoma Gives will include a donor story on David and Dede Del Monte, the Del Monte lecture series and their endowment. Breanne presented and reported on the JC Connect Annual Report and newsletter. She announced there will be new webpages for the SRJC 100<sup>th</sup> Anniversary Campaign and Burbank Auditorium Endowment soon.
